#### **AGREEMENT**

## BY AND BETWEEN

# THE BURNT HILLS BALLSTON LAKE CENTRAL SCHOOL DISTRICT

### AND

## **CSEA**

This Agreement by and between the Burnt Hills-Ballston Lake Central School District ("District"), and CSEA, Local 1000 AFSCME, AFL-CIO, Burnt Hills-Ballston Lake CSD Unit, Schenectady County Local #886 ("CSEA") provides as follows:

### WITNESSETH:

**WHEREAS**, the District and CSEA are parties to a collective bargaining agreement dated July 1, 2023 – June 30, 2027; and

**WHEREAS**, Article 12 of the collective bargaining agreement deals with the Custodial Department, including the establishment of a second shift and corresponding differential; and,

**WHEREAS**, the District has determined that operationally it would be beneficial to the district to have certain custodial employees begin their work day at 1:30pm; and,

**WHEREAS**, the District has identified employees to begin their workday ay 1:30 but who are currently on the second shift and receiving the second shift differential; and

**WHEREAS**, the CSEA has expressed that they do not believe employees should lose their second shift differential if their work day is involuntarily shifted to begin at 1:30pm; and,

**WHEREAS**, the District and CSEA have discussed changing the language contained within Article 12 that addresses the second shift and the corresponding differential; and,

**WHEREAS**, the District and CSEA have discussed the matter and wish to commit the agreement to writing.

#### IT IS HEREBY AGREED AS FOLLOWS:

1. Effective March 1, 2025, Article 12 Section 2 Subsection A shall be replaced with the language below.

# Section 12.02 Staffing and Shift Changes

- (A) In the event a district supervisor makes a change in staffing which requires an employee to change shifts (other than for voluntary, short term/emergent coverage) from day to evening or evening to day, the following definitions will apply and a posting will be required:
  - (i) Day shift a shift that begins in the morning and ends in the afternoon.
  - (ii) Evening shift a shift that begins at 1:30 pm in the afternoon and ends in the evening. At the determination of the district, periodically, on a case by case basis, certain holidays, summer days, etc, second shift hours may be slightly varied for an earlier start time with no loss of the evening differential.
  - (iii) Open/Vacant position a position which is currently available due to one of the following:
    - 1) Retirement.
    - 2) Resignation.
    - 3) Leave of absence.
    - 4) Involuntary termination.
    - 5) A position which is available due to the initial transfer of an employee from one shift to a different shift (as per shift definitions above) due to management prerogative.
    - **6)** A position not previously in force.
